ARTICLES OF INCORPORATION

OF

SUMNER SEAFOOD, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I <u>NAME</u>

The name of the corporation is: Summer Seafcod, Inc.

ARTICLE II DURATION

The corporation shall exist in perpetuity.

ARTICLE III PURPOSE
