ARTICLES OF INCORPORATION

The undersigned incorporator, for purposes of forming a corporation under the Florida Business Corporation Act, and the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I
