**ARTICLES OF INCORPORATION**

The undersigned, acting as the incorporator of GREG'S EXTERIOR ENHANCEMENT, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is:

GREG'S EXTERIOR ENHANCEMENT, INC.

**ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the principal business office and mailing address of the corporation is:

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on November 11, 1996.

**ARTICLE IV. PURPOSE**

The corporation may transact any or all lawful business for which a corporation may be incorporated under the Florida Business Corporation Act.

**ARTICLE V. CORPORATE POWERS**

The corporation has the powers granted to all corporations incorporated under the Florida Business Corporation Act.

**ARTICLE VI. CAPITAL STOCK**

The number of shares of capital stock that the corporation is authorized to issue is 1,000 shares of common stock, having a par value of \$1.00 per share. The consideration to be paid for each share shall be fixed by the Board of Directors and may consist of any tangible or intangible property or benefit to the corporation,

including cash, promissory notes, services performed, other securities of the corporation, or promises to perform services for the corporation that are evidenced by a written contract, with a value, in the judgment of the Board of Directors, that is adequate.

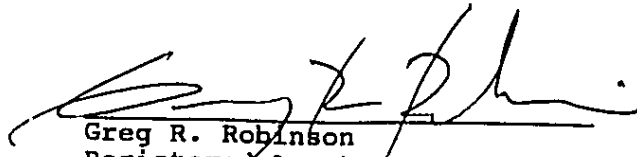
**ACCEPTANCE OF REGISTERED AGENT**
