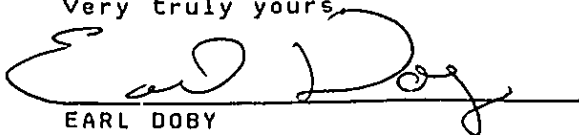

ARTICLE I - NAME

The name of this corporation is DOBY LAND CLEARING, INC.  
with a principal office and mailing address of 11831 WEST STATE  
RD 40, OCALA, FLORIDA 34481

ARTICLE II - DURATION

is corporation shall have perpetual existence commencing on the  
date of the filing of this Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any  
or all lawful business for which corporations may be incorporated  
under Chapter 607, Florida Statutes, as now exists or may after be  
amended.

ARTICLE IV - AUTHORITY OF DIRECTORS

The board, subject to any specific written limitations or  
restrictions imposed by the law or by these Articles of  
Incorporation (articles), shall direct the carrying out of the  
purposes and exercise the powers of the corporation without  
previous authorization or subsequent approval by the shareholders  
of the corporation.

#### ARTICLE V - CAPITAL STOCK

V-1 STOCK CERTIFICATES. Certificates of stock shall be signed by the President or the Vice President, jointly with the Secretary, and the seal of the corporation shall be impressed thereon.

V-2 NUMBER OF AUTHORIZED SHARES.

There must be two classes of common stock: voting and non voting.

The aggregate number of shares that the corporation shall have the authority to issue is 5,000 shares, with \$1.00 par value, of voting stock and the authority to issue 5,000 shares, with \$1.00 par value of non voting stock.

#### ARTICLE VI - PRE - EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial register office of this corporation is 11831 West State road 40, Ocala, Fl. 34481 and the name of the initial registered agent at such address is EARL DOBY.

#### ARTICLE VII - BYLAWS

The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors, except where the shareholders specifically provide in any Bylaw made by them that such Bylaws shall not be altered, amended or repealed by the Board.

#### ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have three Directors constituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the bylaws, however, there shall never be less than one director nor more than ten. 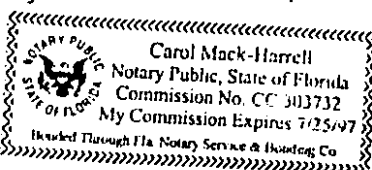

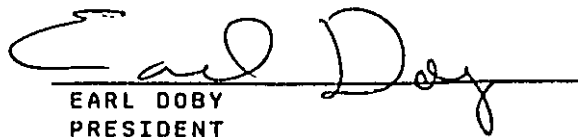
