

Articles of Incorporation

of

Home and Garden Services by the Goose, Inc.



- Article 1: Name. The name of the Corporation is Home and Garden Services by the Goose, Inc.
 - Article 2: Duration. The duration of the Corporation is perpetual.
- Article 3: Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and tranzact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
