ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation shall be K.A.S. OF MANATEE, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles Of Incorporation by the Department of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE
