ARTICLES OF INCORPORATION OF

VENTAVISION PURCHASING, INC.

ARTICLE I

The name of the corporation is VENTAVISION PURCHASING, INC., (hereinafter called the "Corporation").

ARTICLE II

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
