To Whom It May Concern:

Per instructions provided to me by a gentleman named Steve at your (904) 488-9000 number, I have enclosed the filing fee of \$165.00. along with this request for abatement of penalties:

I am a new corporation which incorporated on November 14, 1996. At this time, all filings have been made. Initially, when I filed my corporate papers, I did so listing my old address (606 E. Madison Street, Suite 2001, Tampa, Florida 33602). I have never been involved in another corporation and therefore was not even aware that I needed to file an annual report.

Just recently, I received a "2<sup>ND</sup> NOTICE" indicating that I had not filed my 1997 annual report as of June 27, 1997. This notice came to my correct address (420 West Platt Street, Tampa, Florida 33606). Sometime back in January 1997, I changed office locations. Needless to say, I panicked upon receipt of this second notice first because I never received the "first notice" and second, because the Department of State was assessing a \$385.00 late fee.

I am writing to request that you abate the penalty charges and allow me to file my annual report with the \$165.00 fee. Although ignorance is probably not a defense, I was truly unaware of my need to file by the end of June. I never received the initial annual report filing packet either because it was mailed to my old corporate address and not forwarded to me or for some other reason unknown to me. Still, I honestly never received it. Had I received it, I would have timely filed my annual report. Since my corporation is so new, I have never yet had to file a report and I was not even aware of the need to file same report. For some reason, I just assumed that my accountant would notify me of all tax and corporate filing dates and I now realize that this is not necessarily true. I was not notified by her of this date because she just assumed that I was aware of it. Since I had never been involved in a corporation before and had never been responsible for this type of a filing, I was not aware of same responsibility. Under the above-listed circumstances, I send this plea for abatement of the large penalty. At this time, a \$385.00 late fee would hurt my company financially. I am a very small operation, one that is trying very hard to establish a business from scratch.

Imposition of this penalty would constitute a big hit and would be detrimental to my company.

In the future, I understand the need to file an annual report and I will make sure that it is filed timely in the future.
