The undersigned incorporator hereby makes, subscribes to QRIDA acknowledges, and files these Articles of Incorporation for the purpose of organizing and incorporating a Corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the Corporation is ABSOLUTE FAVORITES, INC., and it shall be hereinafter referred to as the "Corporation".
