

### ARTICLES OF INCORPORATION

OF

# DALE LOVETT ENTERPRISES, INC.

The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

#### **ARTICLE I**

### Name\_of\_Corporation

The name of this Corporation shall be DALE LOVETT ENTERPRISES, INC.(the "Corporation").

#### **ARTICLE II**

# Mailing Address and Principal Place of Business

The mailing address and principal place of business of the Corporation is 2473 Tecumseh Drive, West Palm Beach, Florida 33409.

### **ARTICLE III**

### Purpose

This Corporation is organized for the following purposes:

- (a) To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the Corporation is organized and any and all acts amendatory thereof and supplemental thereto.
  - (b) For the purpose of transacting any or all lawful business.
  - (c) To do any and everything pertinent to the above.
