ARTICLE I -- NAME

The name of this corporation is A Basic Solution, Inc.

ARTICLE II -- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE VIII -- INDEMNIFICATION

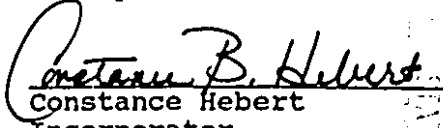
The corporation shall indemnify any Officer or any former officer, to the full extent permitted by law.

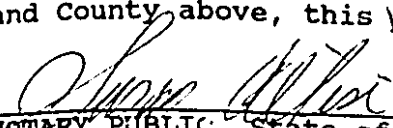

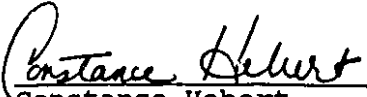
