ARTICLES OF INCORPORATION OF M.T.T. FLOORING CORP.

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is M.T.T. FLOORING CORP.

ARTICLE II

- A. This corporation may engage in any activity or to business permitted under the laws of the State of Florida.
- B. The general nature of this business to be transacted by this corporation is:
