ARTICLES OF INCORPORATION OF ASSOCIATES IN ORTHOPAEDICS AND SPORTS MEDICINE, P.A.

ARTICLE 1 - NAME.

The name of this Professional Association is ASSOCIATES IN ORTHOPAEDICS AND ST 'RTS MEDICINE, P.A.

ARTICLE II - PURPOSE.
