The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. **Name.** The name of this corporation is **J.L.G. of Volusia County, Inc.**
43 Silk Moss Court, South Daytona Beach, FL 32119
2. **Duration.** The period of its duration is perpetual.
3. **Purpose.** The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
4. **Capital Stock.** This corporation is authorized to issue One thousand (1000) shares, all of one class, at one cent (\$0.01) par value.
5. **Initial Registered Office and Agent.** The name and address of the initial registered agent and office of this corporation are as follows:

10. **Effective Date.** The effective date of the incorporation shall be the date of approval by the Secretary of State of Florida.

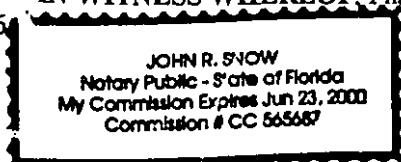

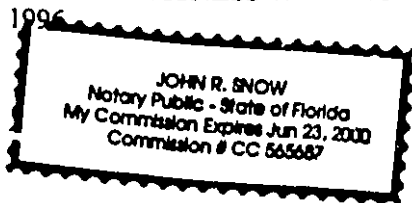


