The undersigned subscriber(s) to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

- 1. The name of the corporation is: FLAGLER CHRISTIAN PRE-SCHOOL AND DAY CARE, INC.
- 2. The general nature of the business to be transacted by this corporation is:
- (a) To engage in every aspect and phase in the supervision, custody and care of children.
- (b) Any other related legal services authorized by the State of Florida.
