**REGISTERED AGENT:**

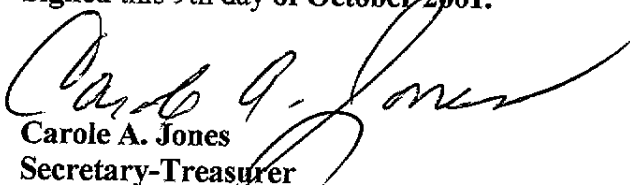
