ARTICLES OF INCORPORATION

OF

ADVENTURE OFF-ROAD INC.

The undersigned, for the purpose of forming a corporation under the Florida of General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: Adventure Off-Road Inc.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporation may be incorporation under the Florida General Corporation Act. No other purpose limited this general purpose in any way.

B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

C. To engage in an Auto/Truck Accessory Business

Article 4. Capital Stock. The aggregate number of shares which the Corporation is authorized to issue is 25,000 shares of common stock. Such shares shall be of a single class and shall have a no par value.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered office of the Corporation is 1100 34th St. S., St. Petersburg, Florida 33711 and the name of its initial Registered Agent at that address is Victor Netschi. This is also the principal office and mailing address for the corporation.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. 
