**ARTICLES OF INCORPORATION
OF
DEERFIELD REHAB CENTER, INC.**

The undersigned, as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation

- I. The name of the Corporation is **DEERFIELD REHAB CENTER, INC.**
- II. The period of its duration is perpetual.
- III. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.
- IV. The maximum authorized capital stock of this corporation shall be five Hundred (500) shares of Common Stock with One Dollar (\$1.00) Par Value.
- V. The initial registered office of this corporation shall be 1050 S.W. 24th Avenue, 3rd Floor, Deerfield Beach, Florida 33442, with the privilege of having branch offices at any other place within or without the State of Florida. 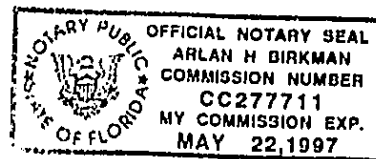
