The undersigned, for the purpose of forming a corporation under Chapter 621, Professional Service Act, does hereby adopt the following Articles of Incorporation:

Article I. Name and Address. The name and address of the Corporation is: Susan A. Brannan, P.A., 8945 Fishermans Bay Drive, Sarasota, Florida 34231.

Article 2. Duration. The duration of the Corporation is perpetual.
