ARTICLE I. NAME

The name of this corporation shall be Las Vegas Artists International, Inc.

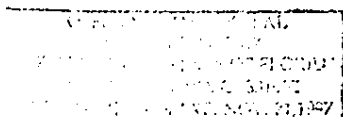


