ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this corporation shall be HOT AND JUICY RACING INCORPORATED.

ARTICLE II. COMMENCEMENT & DURATION

The commoncement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Secretary of State. This corporation's duration shall be perpetual.
