

ARTICLES OF INCORPORATION OF K.R. PRODUCTION, INC.

The undersigned incorporator, a natural person of the age of 18 years or more, in order to form a corporation under the laws of the State of Florida, hereby certifies as follows:

ARTICLE I Name

The name of the corporation is K.R. PRODUCTION, INC. (the "Corporation").

ARTICLE II Period of Duration

The Corporation shall have projetual existence.

ARTICLE III Number of Shares

The aggregate number of shares of all classes which the Corporation shall have authority to issue is 10,000, all of which shall be common shares, no par value per share. Said common shares will be of the same class and shall have full voting power and, upon payment of the consideration fixed by the Board of Directors, shall be fully paid and nonassessable.

Each shareholder of record shall have one vote for each share of stock outstanding in such shareholder's name on the books of the Corporation and entitled to vote.

ARTICLE IV Registered Office and Agent

ARTICLE VI Cumulative Voting

Cumulative voting shall not be allowed in the election of directors.

ARTICLE VII Preemptive Rights

No Shareholders shall have a preemptive right to purchase, subscribe for, or otherwise acquire unissued or treasury shares of the Corporation or securities convertible into such shares or carrying a right to subscribe to or acquire such shares.

ARTICLE VIII Incorporator
