ARTICLE I

NAME: The name of this Corporation is TODAY'S RESOURCE CENTER, INC., and its address is 36045 Fentress Lane, Eustis, Florida 32726.

ARTICLE II

DURATION: This Corporation shall exist perpetually.

ARTICLE III

PURPOSE: The purpose is to engage in any activities or business permitted in the laws of the United States and Florida.

ARTICLE IV

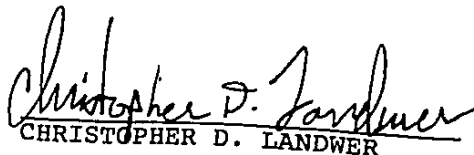
