

INDEMNIFICATION



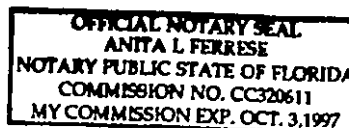


