**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of CHRISTOPH INVESTMENT CORPORATION, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is CHRISTOPH INVESTMENT CORPORATION, INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is 2729 Seville Boulevard #6202, Clearwater, Florida 34624.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10 shares of common stock having One Dollar (\$1.00) par value.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII INITIAL BOARD OF DIRECTORS

ARTICLE IX. BYLAWS




