The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Anticles of Incorporation:

ARTICLE L - CORPORATE NAME

The name of the Corporation is TWIN CITY DINER & BAKER, INC.

ARTICLE II. - CORPORATE DURATION

The duration of the Corporation is perpetual, and the Corporate existence is to commence upon filling hereof, pursuant to F.S. §607,0203 (1991).
