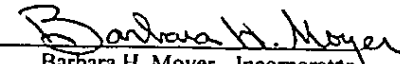

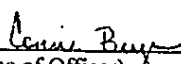
- FIRST: The Corporate name that satisfies the requirements of Section 607.0401 is: Waldec Acquisition Company, Inc.
