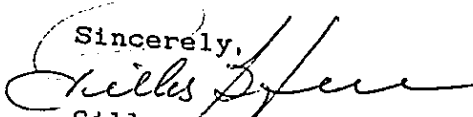

ARTICLES OF INCORPORATION

OF

THE GARDEN PATCH, INC.

ARTICLE I: NAME

The name of this corporation shall be The Garden Patch, Inc.

ARTICLE II: PURPOSE
