On 24 October, 1997, our office received the attached applications for reinstatement for "Skydive Space Center, Inc." and "Skydive Aircraft, Inc.". This office nor our accounting office have any records of receiving prior notification to renew our corporate status.

Just as we are promptly responding to these reinstatement applications, we have promptly responded to all local, state, and federal government request for filing, licensing, registration, etc. This includes the Federal Aviation Administration, and the United States Parachute Association. In as much as we are certain that we never received prior notification for renewal, we request the reinstatement fee of \$585.00 for each corporation be waived.
