#### Article I

The name of this corporation will be The Danio Company, and is referred to herein as the Company.

### Article II

The address of the Company's principal office and its corresponding mailing address are as follows:

#### Article III

The Company is authorized to issue and have outstanding no more than 100 million shares. These shares are non-voting common stock, and will initially be priced at \$1 per share on January 1, 1997, the first day of operation. If the Company's Officer(s) decide through a majority vote to raise more capital, additional shares may be authorized in the future by amending the Articles of Incorporation.

Shares will be purchased through the Company, and they will be sold through the Company. Shares will be priced according to the net asset value at the end of the first business day prior to the day of transaction. Share transactions will take place on a routine basis. In the best interest of investors, the Company will foster a liquid environment for investors by (1) issuing shares when demand exceeds supply during transaction periods, and (2) allowing Treasury to buy back shares when supply exceeds demand during transaction periods. All shares will be priced in the same manner, and again, these actions will only be executed with the investors' best interest in mind.

The purpose of the Company is to provide an investment vehicle that profits through capital investments. Inherent in this Company is the notion that management will not earn money if the Company and its investors are not earning money. Specifically, the Administration Expense Account will be comprised of 25% of all after-tax profit of the Company over the current risk-free rate. The current risk-free rate will be defined as the 90-day Treasury Bill yield as of the beginning of each quarter. This rate will be used throughout the quarter in finding the current administrative expense. This will be simply computed on a quarterly basis. In other words, the quarterly administration account will consist of 25% of all after-tax profits exceeding 1\4 of the current risk-free rate for that quarter.

#### ArticleVIII

The power to operate the Company lies directly in the hands of the Officer(s). The Company's Officer(s) will make all decisions regarding operations, and if additional Officers are needed, they will be named by the incorporator and initial Officer, Christopher Snively.

There are no plans to have a Board of Directors, but if the need arises, the Company's Officer(s) will elect a Board pursuant to all rules regarding investment companies. The shareholders have no voting rights. While shares constitute ownership of the Company's assets, they do not carry any voting power with regard to operations of the Company.

#### Article IX

The effective date of incorporation for these Articles of Incorporation shall be January 1, 1997.

#### Article X

Officers (and Directors) of the Company will not be exposed to any liability that may arise from a loss of shareholder value. It will also be Company policy that all shareholders are made fully aware of the risks associated with investing in a Company that invests in the stock market.

Investments made by the Company will not include short-selling, buying on margin, or options trading.

#### Article XI

The Articles of Incorporation may be amended at any time through a majority vote of the Company's Officer(s).
