The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is:

ARTICLE TWO

The term of existence of the corporation is perpetual.

ARTICLE THREE

The corporation shall be deemed to commence it's existence on November 22, 1996.




