The undersigned, for the purpose of forming a Professional Service Corporation under the Florida General Corporation Act, and Florida Statute Chapter Section 621, does hereby adopt the following Articles of Incorporation:

ARTICLE 1. Name. The name of the Corporation is: **DAVID K. KUSCHEL P.A.**

ARTICLE 2. Duration. The duration of the Professional Service Corporation is perpetual.

ARTICLE 3. Purpose. The general purposes for which the Professional Service Corporation is organized are the following:

A. To engage in and transact any lawful business for which Professional Service Corporations engaged in the field of legal and accounting services may be formed under the Florida General Corporation Act and Professional Service Corporation Section of the Florida Statutes.

B. To do such other things as are incidental to the purposes of the Professional Service Corporation in rendering professional services or necessary or desirable in order to accomplish them.

ARTICLE 4. Capital Stock. The aggregate number of shares which the Professional Service Corporation is authorized to issue is 1,000 shares of common stock. Such shares shall be a single class and shall have a par value of \$1.00 per share.

ARTICLE 5. Initial Registered/Principal Office and Agent. The street address of the initial Principal Office of the Corporation is 27 Pennock Lane, Suite 204, Jupiter, FL 33458, and the name of its initial Registered Agent is David K. Kuschel Esq., who also maintains an office at 27 Pennock Lane, Suite 204, Jupiter, FL 33458.

ARTICLE 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. The name and address of the initial Director of the Professional Service Corporation is as follows:
