## ARTICLES OF INCORPORATION

OF

# B & L DRYWALL & METAL FRAMING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE:

The name of the Corporation is B & L DRYWALL & METAL FRAMING, INC.

#### ARTICLE TWO:

The duration of the corporation is perpetual with commencement at the time of filing these Articles.

### ARTICLE THREE:

The general purposes for which the corporation is organized are:

- 1. To engage in any or all of the aspe ts of drywall and metal framing.
- 2.
