

ARTICLES OF INCORPORATION

OF

GEORGE KAKOURIS VIDEOGRAPHY INC.

EFFECTIVE DATE

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

ARTICLE ONE NAME

The name of the corporation is: GEORGE KAKOURIS VIDEOGRAPHY INC.
