

**ARTICLE I  
NAME OF CORPORATION**

The name of this corporation is PDQ Marketing of the United States, Inc. (hereinafter called the "Corporation").

**ARTICLE II  
PERIOD OF DURATION**

The duration of the Corporation shall be perpetual.

The effective date of the Corporation shall be the date of subscription and acknowledgement.

**ARTICLE III  
PURPOSES**

The Corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

**ARTICLE IV  
AUTHORIZED STOCK**

The aggregate number of shares which the Corporation shall be authorized to issue is Seven Thousand Five Hundred (7,500) shares of common stock with a par value of One Dollar (\$1.00) per share.

**ARTICLE V  
CAPITAL**

The amount of capital with which the Corporation shall begin business shall be Five Hundred Dollars (\$500.00).

## **ARTICLE VI**

### **BOARD OF DIRECTORS**

The affairs of the Corporation shall be conducted by a Board of Directors composed of not less than one (1) person, who need not be a Stockholder. The number of Directors may be increased or decreased from time to time by the By-Laws adopted by the Stockholders, but shall never be less than one (1) person and none of the Directors need be Stockholders.

## **ARTICLE VII**

### **INCORPORATOR**

## **ARTICLE VIII**

### **PRINCIPLE PLACE OF BUSINESS**

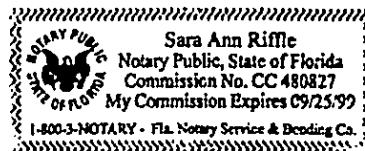
