ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, do hereby adopt the following Articles of Incorporation: CORAL REEF DEVELOPMENT CORP.

ARTICLE ONE

The name of the corporation is: CORAL REEF DEVELOPMENT CORP.

The duration of the corporation is perpetual.

The general purposes for which the corporation is organized are:

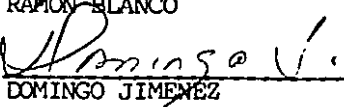

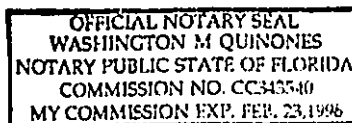
