ARTICLE I. NAME

The name of this corporation shall be "ISA'S CUSTOM CABINET MFG., INC., a Florida corporation located at 1509 Pine Avenue, Orlando, Florida 32824.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of manufacturing custom cabinets and engaging in any and all business activities permitted under the laws of Florida and the United States Of America.

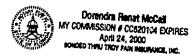
