ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of this corporation is NATIONWIDE COLLISION & APPRAISAL, INC.

ARTICLE TWO

The corporation is to have perpetual existence.

ARTICLE THREE

The corporation may transact any and all lawful business for which corporations may be incorporated under chapter 607, Florida Statutes and engage in any trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business. The corporation shall also be authorized to engage in such other business activities as may be necessary or permissible for its operation.

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 2,000 shares of common stock having a par value of \$1 per share. All such shares shall be of a single class and of equal right and power.

4.02 The shareholders shall be empowered to manage the affairs of the corporation in lieu of the directors or until the board of directors is elected by the shareholders. The name and address of the initial shareholder and incorporator of

#### ARTICLE FIVE

#### ARTICLE SIX

The Bylaws may provide for such increase or change, from time to time, in number of directors as is authorized by law.

#### ARTICLE EIGHT

The capital stock of the Corporation shall be subject to the restrictions upon the sale, pledge, assignment, transfer or other disposition thereof contained in the Bylaws of the Corporation, which are maintained at the principal corporate office of the Corporation.

#### ARTICLE NINE

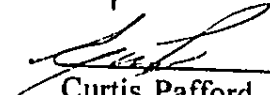
Nothing in these Articles of Incorporation shall be taken to limit the power

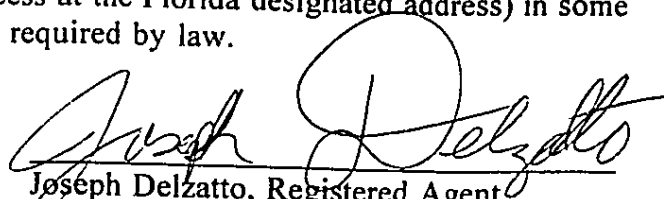
