The undersigned hereby makes and subscribes these Articles of Incorporation intending to form a professional service corporation under the provisions of Chapter 621, Florida Statutes.

**ARTICLE I - NAME**

The name of this corporation is IMAGING CONSULTANTS OF OSCEOLA, P.A.

**ARTICLE II - PURPOSE**

The purpose of the corporation is to provide radiology-related medical services to the public. While engaging in such activity or business, it may exercise all of the powers and privileges conferred by Chapter 621, Florida Statutes, as presently in effect and as it may be amended from time to time in the future.

**ARTICLE III - CAPITAL STOCK**

The corporation is authorized to issue one thousand (1,000) shares of common stock, each share having a par value of \$1.00.

**ARTICLE IV - DURATION**

The corporation is to have perpetual existence, beginning in accordance with law.

**ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT**

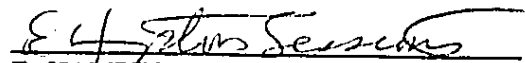

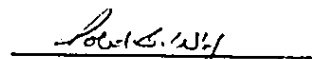
