The name of the corporation is Intertech Communications Consultants, Inc., but said corporation may use such other names, marks and designations as is authorized by the corporate By-Laws and laws of the State of Florida.

ARTICLE TWO

The period of its duration is perpetual unless dissolved voluntarily or by action of law. This corporation shall commence its corporate existence upon filing with the secretary of State of the State of Florida.
