The name of the corporation is: Central Florida Lawn Management, Inc.

This corporation shall have perpetual existence.





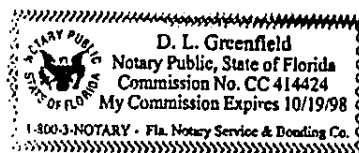
