Article I  
Name

The name of this Corporation is CUSCADEN PARK INVESTMENTS, INC.

Article II  
Duration

The Corporation shall have perpetual existence.

Article III  
Purpose and Principal Place of Business

Purpose. This Corporation is organized for the purposes of transacting any or all lawful business.

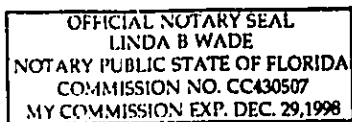

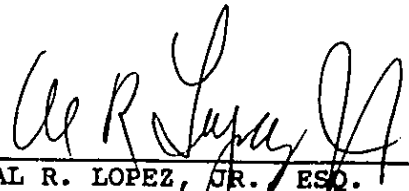
