ARTICLES OF INCORPORATION

OF

K C MARKETING GROUP INC.

The undersigned for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be K C MARKETING GROUP INC.

ARTICLE II. NATURE OF BUSINESS

The general purposes for which the corporation is organized are the following:

- A. To engage in the promotion and marketing of vacations and other promotional activities and services;
- B. To engage in or transact any lawful activities or business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way;
- C. To do such other things as are incidental to the purposes of the corporation or necessary or desirable in order to accomplish them.

ARTICLE III. CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares of common stock of no par value per share.

ARTICLE IV. INITIAL REGISTERED OFFICE AND AGENT AND PRINCIPLE OFFICE

ARTICLE V. TERM OF EXISTENCE

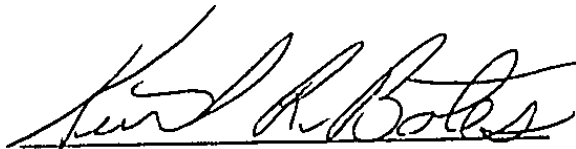

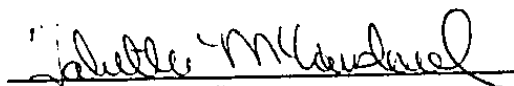
ARTICLE IX. AMENDMENT

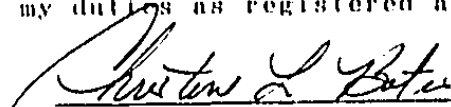
