ARTICLES OF INCORPORATION

OF

ADVANCED MEDICAL HAIR CENTERS OF WEST FLORIDA, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation shall be ADVANCED MEDICAL HAIR CENTERS OF WEST FLORIDA, INC.

ARTICLE II.

NATURE OF BUSINESS
