ARTICLE I

The name of the corporation is SMALL BUSINESS ACCOUNTING AND TAXES, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE III - CAPITAL STOCK

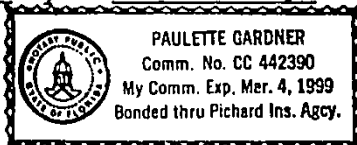
