ARTICLE I - NAME

The name of this corporation is Fax of Shipping, Inc.

ARTICLE II - DURATION

The duration of this corporation is perpetual.

ARTICLE III - PRINCIPAL OFFICE AND REGISTERED OFFICE OF AGENT


