ARTICLES of INCORPORATION
of

The undersigned incorporators under these Articles of Incorporation, in order to form a corporation under the laws of Florida, hereby certify:

ARTICLE 1 - The name of the corporation is:

TRINIDAD & TOBAGO AIR-OCEAN SERVICES, Inc.

ARTICLE 2 - This corporation is to exist perpetually.

ARTICLE 3 - The general purposes for which this corporation is organized is:

(a) To engage in the business of freight forwarding, transportation and movement of cargo; furnishing every kind of support service to airlines, including, but not limited to administration, office personnel, cargo handling, aircraft maintenance, ticket handling, cargo and passenger ticket sales and promotion, import and export documentation and services, custom documentation and any other service in connection with the airline business, both passenger and cargo, both at wholesale or retail, as principal or agent, and any other business in connection therewith.
