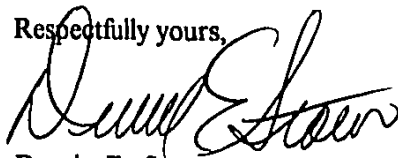

**ARTICLES OF INCORPORATION
OF
SIGNATURE FARMS, INC.**

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of incorporation for such corporation:

ARTICLE I - NAME

The name of this Corporation is: **SIGNATURE FARMS, INC.**

ARTICLE II - ADDRESS

The street address of the initial principal office and the mailing address of the corporation is: 18210 S.W. 216 Street, Miami, FL 33170.

ARTICLE III - NUMBER OF SHARES

The number of shares the corporation is authorized to issue is 1,000 shares of common stock having \$1.00 par value per share.

ARTICLE IV - DURATION

The period of duration of this Corporation is perpetual.

ARTICLE V - NATURE OF BUSINESS
