
ARTICLE XI. AMENDMENTS

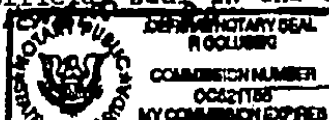
