ARTICLES OF INCORPORATION  
OF  
Southern TradeWINS, Inc.

ARTICLE I  
NAME AND ADDRESS

The name of this corporation is Southern TradeWINS, Inc. and the address of the corporation is 16537 Northwest 7 Street, Pembroke Pines, Florida 33028.

ARTICLE II  
DURATION

The corporation shall have perpetual existence.

ARTICLE III  
PURPOSE

The purpose of this corporation is to engage in any activities or businesses permitted under the laws of the United States and the State of Florida.

ARTICLE IV  
CAPITAL STOCK

The maximum number of shares which this corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE V  
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be 16537 Northwest 7 Street, Pembroke Pines, Florida 33028 and the initial registered agent of this corporation shall be Ainsworth Palmer, located at 16537 Northwest 7 Street, Pembroke Pines, Florida 33028, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.




